# Admission Policy of Gunma University

We seek applicants who have academic skills and capabilities required by the graduate schools, institutes or the interfaculty initiative according to their programs or specialties. Applicants should be motivated to contribute to the development of society through research and practice.

## Admission Policy for Course of Medical Sciences in Graduate School of Medicine, Gunma University (Doctoral Program)

### < Aims in Human Resources Development >

Our program aims to cultivate medical doctors who will pursue medical science, medical ethics, and medical skills. We hope our graduates will integrate these pursuits and contribute to the progress of medical research and education, thereby becoming leaders in health care and medical science.

### < Attributes of Desired Candidate >

We will accept students who have profound academic knowledge and skills in medical sciences to study and research in our program. Specifically, we will accept those who:

1. strive to contribute to human and societal development through advanced biological science and medical sciences.
2. strive to contribute to human and societal development as medical professionals with high ethical standards and great clinical capabilities.
3. strive to contribute to human and societal development as medical educators who cultivate respectable doctors and healthcare professionals.
4. have English proficiency as a basis for academic discussion and literature reading.

### < Basic Policy for Admission Selection >

In order to select applicants with the above qualities, we will conduct the entrance examinations for working members of society in addition to the general entrance examination. We offer October admission in addition to the traditional April admission, to expand learning opportunities. We will make comprehensive evaluation based on the results of the entrance examination (English test and interview) and undergraduate (graduate) academic transcripts.

### ○General entrance examination, Entrance examination for working members of society

The foreign language (English) examination will evaluate "reading comprehension of literature in English" (Attributes of Desired Candidate 4). The oral examination (interview) will evaluate the applicant's basic academic knowledge related to the major field of study and the willingness to engage in research (Attributes of Desired Candidate 1-3). Furthermore, the transcripts will be added for a comprehensive judgment.

## **2 Qualifications for Application (A person who is applicable to any of the following provisions or a person who will be applicable by September 30, 2026)**

- (1) A person who has graduated from a university (that has a course in medical science or dental science, or a 6-year course in pharmaceutical science or veterinary science).
- (2) A person who has completed an 18-year course (final course has to be the course in medical science, dental science, pharmaceutical science, or veterinary science) of school education in a foreign country.
- (3) A person who has completed an 18-year course (final course has to be the course in medical science, dental science, pharmaceutical science, or veterinary science) in a foreign country's school education by taking subjects in Japan through correspondence courses run by the said foreign educational institution.
- (4) A person who has completed a foreign country's university course at an educational institution in Japan [limited to the person who has completed an 18-year course of school education (including the doctoral course to study medical science, dental science, pharmaceutical science, or veterinary science) in the said foreign country's school education] that is designated in the said foreign country's education system as having a foreign university's curriculum and specifically designated by the Minister of Education, Culture, Sports, Science and Technology, Japan.
- (5) A person who has completed five or more years of study (the course in medical science, dental science, pharmaceutical science, or veterinary science) at a foreign university, or foreign educational institution (including a person who, while residing in Japan, has completed the program of education provided by a foreign university or foreign educational institution through correspondence or distance education courses) and who received a degree certificate that is recognized by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (6) A person designated by the Minister of Education, Culture, Sports, Science and Technology, Japan. (Notification No. 39 of the Ministry of Education, 1955)  
(Note) The designated person above refers to a person who falls under any of the following provisions:
  - (a) A person who has completed medical science or dental science at the faculty of medicine or dentistry of a university under the old University Ordinance (Imperial Ordinance No. 388 of 1918), and who has graduated from these faculties.
  - (b) A person who has graduated from the National Defense Medical College under the Act for Establishment of the Ministry of Defense (Act No. 164 of 1954)
  - (c) A person who has completed a master's course, a person who can be awarded a master's degree, or a person who has been enrolled in the doctoral course with no separation of a 2 year-first semester and a 3 year-second semester for 2 years or longer acquiring 30 credits or more under the necessary research guidance (including a person who falls under Article 6-1 of the Degree regulations (Ordinance of the Ministry of Education, Science, Culture No. 9 of 1953) prior to the version by Ministerial Ordinance (Ordinance of the Ministry of Education, Science, Culture No. 29 of 1974) that revises part of the Degree regulations); in addition to the above-described premises, a person who has been recognized by our Graduate School as having academic ability equivalent or superior to a university graduate who has completed the course to study medical science, dental science, pharmaceutical science, or veterinary science.
  - (d) A person who has graduated from a university (excluding the course to study medical science or dental science, or a 6-year course in pharmaceutical science or veterinary science), and has been engaged in research for 2 years or longer at university or institute, etc. after having completed 16 years of a school education in a foreign country; in addition to the above-described premises, a person who has been recognized by our Graduate School as having academic ability equivalent or superior to a university graduate who has completed the course in medical science, dental science, pharmaceutical science, or veterinary science based on the said research's results, etc.
- (7) A person who entered a graduate school other than our Graduate School (limited to the course to study medical science, dental science, pharmaceutical science, or veterinary science) based on the provisions of Article 102-2 of the School Education Act (Act No. 26 of 1947) and who has been recognized by our Graduate School as having academic abilities appropriate for receiving graduate school education.
- (8) A person who has been recognized by our Graduate School as having academic abilities equivalent or superior to a person who has graduated from a university (that has a course in medical science or dental science, or a 6-year course in pharmaceutical science or veterinary science) based on the results of individual screening of the applicant's qualifications, and who will be 24 years of age.
- (9) A person who has been enrolled at a university for 4 years or longer taking the course in medical science or dental science, or the 6-year course in pharmaceutical science/ veterinary science (including a person who is specified by the Minister of Education, Culture, Sports, Science and Technology, Japan as any other person equivalent thereto) and who has been recognized by Gunma University as having completed the required units with excellent results.

### 3 Application requirements

Applicants must have the following points of any of the private English test's score, TOEFL ITP (TOEFL Institutional Testing Program), TOEFL iBT (internet Based Test), TOEIC L&R(Listening & Reading Test), TOEIC IP (only administered by Gunma University), or IELTS (Academic Module (including Computer-delivered IELTS Academic)) for applying.

Furthermore, the valid score report is issued within five years.

### 4 Screening etc. of "Qualifications for Application" (only if applicable)

- (1) A person who intends to apply under the provisions of Qualifications for Application (6)-(c)(d), (7), or (8) must undergo the screening of requirements for admission of our Graduate School before applying under the following conditions. Afterwards, only the person proven to have the Qualifications for Application can apply. Furthermore, each applicant will be notified of the qualification screening results by May 15 (Fri.), 2026.

      - VI Graduation Certificate or Completion Certificate issued by the final educational institution from which the applicant graduated.
      - VII Academic transcript issued by the final educational institution from which the applicant graduated.
      - VIII Other documents
    - ② In the case of the screening concerning Qualifications for Application (7):
      - I Application for the screening of admission requirements and Curriculum Vitae (The form attached to our application guidelines must be used.([Form-7-1] [Form-7-2]) )
      - II Academic transcript (faculty results and the document showing the curriculum of the faculty (e.g. syllabus))
      - III Certificate of student status (issued by the president of the university (graduate school) the applicant is in along with the date of entrance). If the applicant has completed or quit the graduate school, submit the document with the date of entrance (e.g. the transcript from the graduate school).

(2) Submission Procedures of Application documents


Application documents must be submitted only by postal mail within the application period. Bringing Application documents in person or by proxy is unacceptable.

## 7 Selection Method

The admission decision will be based on a comprehensive evaluation of the applicant's English language test score, oral examination, and academic transcripts from their previous institution(s). The foreign language (English) examination will not be held on the day of the examination.

(1) English Language Examination

Applicants who submit a valid English test score report from TOEFL ITP (TOEFL Institutional Testing Program), TOEFL iBT (internet-based test including Home Edition), TOEIC Listening & Reading Test, TOEIC IP test (excluding the online version), or IELTS (Academic Module, including Computer-delivered IELTS Academic) at the time of application may have their scores converted and used as the foreign language (English) examination score, provided that the score meets the minimum standards specified in the table below.

(2) About the oral examination

① For applicants with difficulty coming to the Showa campus for the Gunma University oral examination, we may use the results of the interview on the internet for evaluation.

② Date of examination

The examination is held on the same day as the general entrance examination. However, the schedule for the virtual interview is determined individually.

# Admission Guidelines for Working Members of Society

## Aim

With the rapid development of medical science and medical treatment, the development of human resources with the special ability, knowledge, and technique of more advanced medical science and medical treatment is socially requested.

Our Graduate School introduces the day/evening lecture course system based on the special divisions on education methods by Article 14 of the Standards Act for Establishment of Graduate School. It conducts the selection for a working member who is active in the field connected to medical science and medical treatment in local society to give him/her an opportunity to learn the ability, knowledge, and technique of advanced medical science and medical treatment.

The education based on the day/evening lecture course system will be implemented in the evening (5:30 p.m.-8:35 p.m.), on Saturdays, Sundays, national holidays, and during the period of absence from work; for example during summer holidays.

## 1 Number of Students to be Admitted

The number of the students to be admitted for the selection of working members of society is included in the number of students to be admitted described in the Admission Guidelines for general selection.

**Note: When applying, inquire with the supervisor of the desired major field about research and guidance, etc.**

## 2 Qualifications for Application

**A person applying for admission should fall under any of the following scenarios or a person who will be applicable to by September 30, 2026, and who has been working for a hospital, a clinic, a research institute, an educational institution, or a health center, etc. upon applying. Furthermore, after entering our graduate school, they shall retain his/her status with excellent work and be approved to take the entrance examination and attend school by the supervisor or appointer of the workplace.**

- (1) A person who has graduated from a university (which has a course in medical science or dental science, or a 6-year course in pharmaceutical science or veterinary science).
- (2) A person who completed an 18-year course (its final course has to be the course in medical science, dental science, pharmaceutical science, or veterinary science) of school education in a foreign country.
- (3) A person who completed an 18-year course (its final course has to be the course in medical science, dental science, pharmaceutical science, or veterinary science) in a foreign country's school education by taking class subjects in Japan through correspondence courses run by the said foreign educational institution.
- (4) A person who completed a foreign country's university course at an educational institution in Japan (limited to the person who has completed an 18-year course of school education (including the doctoral course to study medical science, dental science, pharmaceutical science, or veterinary science) in the said foreign country's school education), which is designated in the said foreign country's education system as having a foreign university's curriculum and specifically designated by the Minister of Education, Culture, Sports, Science and Technology, Japan.
- (5) A person who has completed five or more years of study (the course in medical science, dental science, pharmaceutical science, or veterinary science) at a foreign university, or foreign educational institution (including a person who, while residing in Japan, has completed the program of education provided by a foreign university or foreign educational institution through correspondence or distance education courses), and who received a degree certificate that is recognized by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- (6) A person designated by the Minister of Education, Culture, Sports, Science and Technology, Japan. (Notification No. 39 of the Ministry of Education, 1955)  
(Note) The designated person above refers to a person who falls under any of the following provisions:
  - (a) A person who completed medical science or dental science at the faculty of medicine or dentistry of a university under the old University Ordinance (Imperial Ordinance No. 388 of 1918), and who graduated from these faculties.
  - (b) A person who graduated from National Defense Medical College under the Act for Establishment of the Ministry of Defense (Act No. 164 of 1954)
  - (c) A person who completed a master's course, can be awarded a master's degree, or who had been enrolled in the doctoral course without dividing the course between 2 years' first semester and 3 years' second semester for 2 years or longer acquiring 30 credits or more under the necessary research guidance (including a person who falls under Article 6-1 of the Degree regulations (Ordinance of the Ministry of Education, Science, Culture No. 9 of 1953) prior to version by Ministerial Ordinance (Ordinance of the Ministry of Education, Science, Culture No. 29 of 1974) that revises part of the Degree regulations), in addition to the above-described premises, a person who has been recognized by our Graduate School as having academic ability equivalent or superior to a university graduate who has completed the course to study medical science, dental science, pharmaceutical science, or veterinary science.

- (d) A person who graduated from a university (excluding the course to study medical science or dental science, or a 6-year course in pharmaceutical science or veterinary science), and has been engaged in research for 2 years or longer at any university or institute, etc. after having completed 16 years of a school education in a foreign country : in addition to the above-described premises, a person who has been recognized by our Graduate School as having academic ability equivalent or superior to a university graduate who has completed the course in medical science, dental science, pharmaceutical science, or veterinary science based on the said research's results, etc.
- (7) A person who has been recognized by our Graduate School as having academic abilities equivalent or superior to a person who has graduated a university (which has a course in medical science or dental science, or a 6-year course in pharmaceutical science or veterinary science) based on the results of individual screening of the applicant's qualifications and who will be 24 years of age.

### 3 Application requirements

Applicants must have the following points of any of the private English test's score, TOEFL ITP (TOEFL Institutional Testing Program), TOEFL iBT (internet Based Test), TOEIC L&R(Listening & Reading Test), TOEIC IP (only administered by Gunma University), or IELTS (Academic Module (including Computer-delivered IELTS Academic)) for applying.

Furthermore, the valid score report is issued within five years.

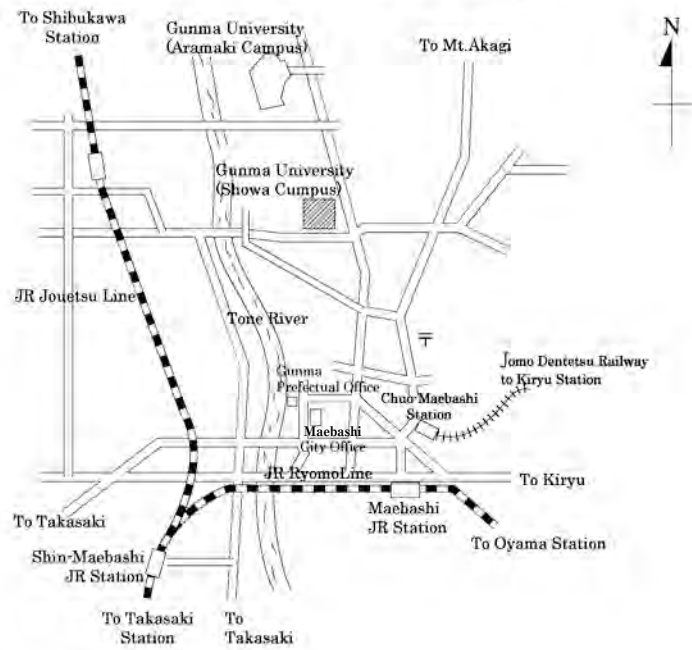

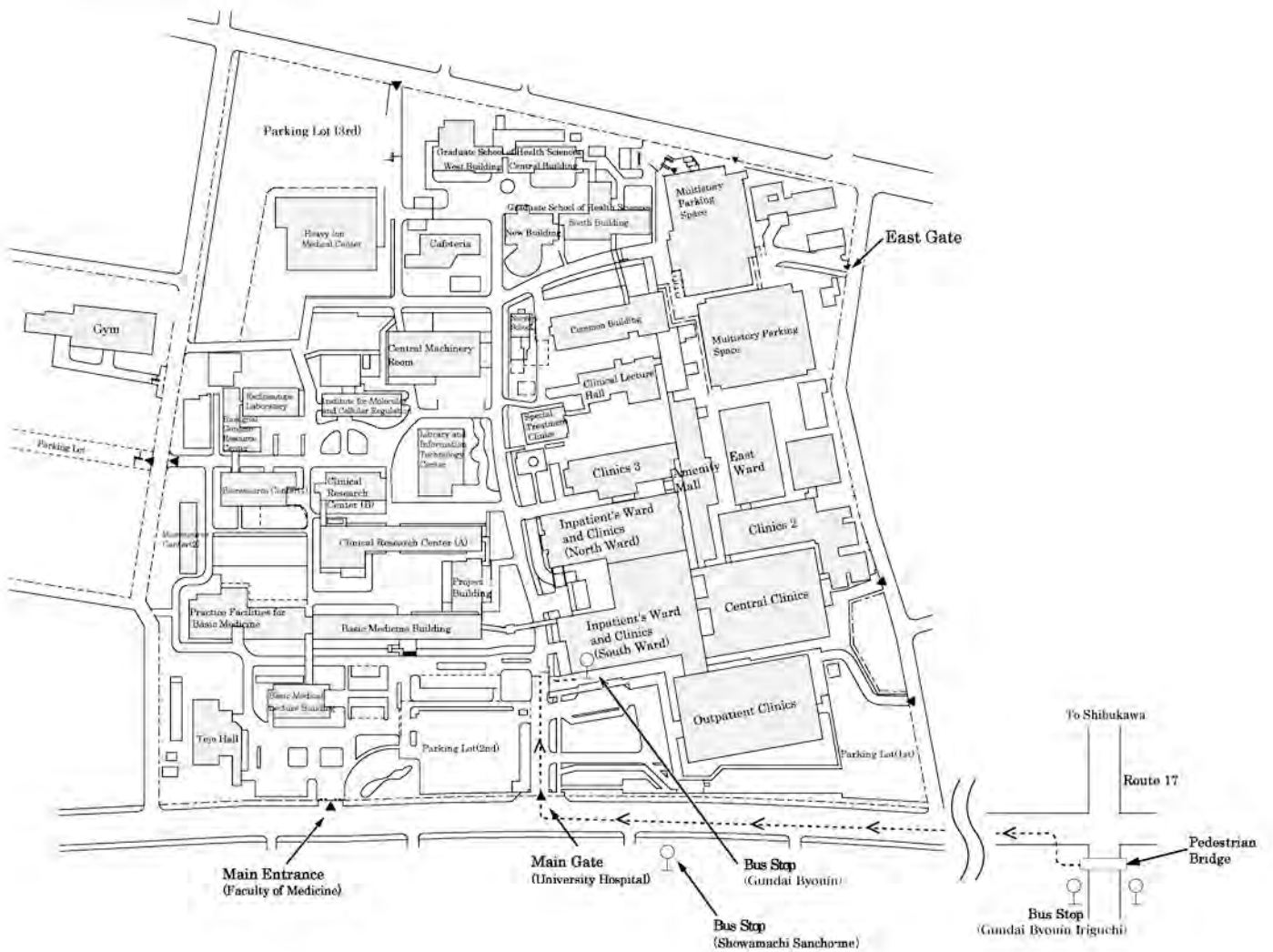

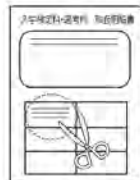
